

# **Summit County Public Health Influenza Surveillance Report**

2020 - 2021 Season





# Flu Surveillance Weeks 10 & 11 (12/6/2020 to 12/19/2020) Centers for Disease Control and Prevention MMWR Weeks 50 & 51

## **Summit County Surveillance Data:**

During Week 11 of influenza surveillance, influenza-related activity was minimal in Summit County, and COVID-19 activity remained high with continued elevated risk of community exposure.

**Note:** Data is provisional and may be updated as more information is received. Percentages should be interpreted with caution. Small changes in number can result in large changes in percent. When a percentage, or prevalence, is available in this table, the percent change will be calculated from those values

Lab reports: During the Week 11, reporting Summit County facilities ordered influenza 652 tests, of which one had positive result (Type B). 2,074 COVID-19 tests were completed by reporting partners, with a positivity rate of 15.7% in Week 11 (a 19.2% decrease from Week 10) (Fig. 4)

Note: Influenza and COVID-19 testing data are collected from selected reporting partners and do not represent positivity rates for the entire county.

Acute Care Hospitalizations: There was zero reported influenza and 285 COVID-19 admissions during Week 11. Figure 2 displays hospitalizations in Summit County.

**Pharmacies:** Zero prescriptions for CDC- approved influenza antiviral medications were reported during Week 11.

School absenteeism includes absences regardless of reason. In Week 11, the absence rate was 6.2%, a 1.8% decrease from Wk 10.


**Zero** deaths related to influenza, 68 COVID-19 deaths and 34 pneumonia related deaths were reported during Wk 11. The rates of pneumonia deaths decreased by 19.5% and the COVID-19 associated death rate decreased by 3.9%.

**Figure 1** displays weekly counts of deaths occurring in Summit County associated with pneumonia, COVID-19 and influenza.



Figure 1. Weekly Summit County death counts associated with pneumonia and influenza during 2020-2021 season




**Hospitalizations**: Summit County hospitals reported no influenza-associated hospitalizations, and 285 COVID-19 admissions in Week 11. **Figure 2** displays weekly confirmed hospitalization counts for Summit County (influenza total count to date = 1).



**EpiCenter** collects and analyzes health related data in real time to provide information about the health of the community. This system tracks ER visits related to constitutional complaints and fever and ILI. **Figure 3** displays the weekly number of ER visits related to ILI and flu symptoms in Summit County. There were 59 ILI-related visits reported during Week 11, which was 1.1% of total ED visits (n = 5332). This rate was 4.4% lower than the ILI rate during Week 10.

## Ohio Influenza Activity: from the Ohio Department of Health:

### Current Ohio Activity Level (Geographic Spread) - Minimal

During MMWR Week 51, public health surveillance data sources indicate minimal intensity for influenza-like illness (ILI) in outpatient settings reported by Ohio's sentinel providers. Data from public health and clinical laboratories show very low levels of influenza virus circulation. The percentage of emergency department visits with patients exhibiting constitutional symptoms decreased slightly and are now below baseline levels; fever and ILI specified ED visits decreased and are below baseline levels. Reported cases of influenza-associated hospitalizations are below the seasonal threshold\*. There were 7 influenza-associated hospitalization reported during MMWR Week 51.

## **Ohio Surveillance Data:**

- The Ohio Department of Health Laboratory has tested three specimens for influenza during the 2020-2021 influenza season; of these, 0 tested positive for influenza A(H1N1pdm09), 0 for influenza A(H3N2), 1 for influenza B, and 2 were negative (through 12/19/2020).
- The National Respiratory and Enteric Virus Surveillance System (NREVSS) and U.S. World Health Organization (WHO) Collaborating Laboratories reported 13,899 tests for influenza performed at participating facilities; of these, 0 tested positive for influenza A(H1N1pdm09), 2 for influenza A(H3N2), 28 for influenza A (subtyping not performed), and 15 for influenza B (as of 12/11/2020; 2020-2021 season positive influenza testing data reflects a two-week lag to ensure data completeness).
- No pediatric influenza-associated mortalities have been reported so far during the 2020-2021 influenza season (through 12/19/2020).
- No novel influenza A virus infections have been reported so far during the 2020-2021 influenza season (through 12/19/2020).
- Incidence of confirmed influenza-associated hospitalizations in 2020-2021 season = 49 (through 12/19/2020).


## National Surveillance: from Centers for Disease Control and Prevention (CDC):

Seasonal influenza activity in the United States remains lower than usual for this time of year.

#### **National Outpatient Illness Surveillance:**

During week 51, the percentage of outpatient visits for ILI decreased to 1.5% (Figure 5), which is below the national baseline of 2.6%. During week 51 compared with week 50, one region (Region 2) had an increase in the percentage of visits for ILI, one region (Regions 6) had a decrease in percentage of visits for ILI, and the remaining regions remained stable (change of  $\leq$  0.1%). All 10 regions reported a percentage of outpatient visits for ILI below their region-specific baselines. In Week 51, all states and territories experienced minimal activity as reported by sentinel ILINet providers (Figure 6).

## **Global Surveillance:**

Influenza Update N° 383, World Health Organization (WHO), published December 21, 2020, based on data up to December 6, 2020. The Update is published every two weeks.


#### **Summary**

The current influenza surveillance data should be interpreted with caution as the ongoing COVID-19 pandemic has influenced to varying extents health seeking behaviours, staffing/routines in sentinel sites, as well as testing priorities and capacities in Member States. The various hygiene and physical distancing measures implemented by Member States to reduce SARS-CoV-2 virus transmission have likely played a role in reducing influenza virus transmission.

- Globally, despite continued or even increased testing for influenza in some countries, influenza activity remained at lower levels than expected for this time of the year.
- In the temperate zone of the northern hemisphere, influenza activity remained below inter-seasonal levels, though sporadic detections of influenza A and B viruses were reported in some countries.
- In the temperate zone of the southern hemisphere, influenza activity was reported at inter-seasonal level.
- In the Caribbean and Central American countries, sporadic influenza B detections were reported in recent weeks. Severe acute respiratory infection (SARI) activity, likely due to COVID-19, was elevated in some reporting countries
- In tropical South America, there were no influenza detections in this reporting period.
- In tropical Africa, influenza activity continued to be reported in Western Africa.
- In Southern Asia, no influenza detections were reported.
- In South East Asia, influenza detections of predominately influenza A(H3N2) continued to be reported in Lao People's Democratic Republic (PDR).
- Worldwide, influenza A and B viruses were detected in similar proportions.

• National Influenza Centres (NICs) and other national influenza laboratories from 87 countries, areas or territories reported data to FluNet for the time period from 23 November 2020 to 06 December 2020 (data as of 2020-12-21 10:42:23 UTC). The WHO GISRS laboratories tested more than 204150 specimens during that time period. A total of 385 specimens were positive for influenza viruses, of which 189 (49.1%) were typed as influenza A and 196 (50.9%) as influenza B. Of the sub-typed influenza A viruses, 16 (19.3%) were influenza A(H1N1)pdm09 and 67 (80.7%) were influenza A(H3N2). Of the characterized B viruses, 3 (10.3%) belonged to the B-Yamagata lineage and 26 (89.7%) to the B-Victoria lineage.

**About this report:** Reporting agencies include labs, hospitals, long-term care and community-based care providers, physician offices, university clinic, pharmacies, and schools. Agencies are distributed throughout Summit County and report different indicators of flu activity including total lab tests, numbers of positive tests and type, antiviral prescriptions filled, school absences, and influenza like illness (ILI). Hospitalizations are lab confirmed for influenza and are obtained from the Ohio Disease Reporting System. Number of deaths associated with influenza and pneumonia are gathered from the Summit County Office of Vital Records death listings. Emergency room visits for complaints related to influenza are obtained by syndromic surveillance system (Epicenter).
